### 284 Renin-Angiotensin System-Modifying Antihypertensive Drugs Can Reduce the Risk of Cardiovascular Complications in Lupus: A Retrospective Cohort Study

*Currently available colorectal cancer risk calculators are more consistent in estimating risk for shorter time frames (5-10 years) than for longer time frames (lifetime). The National Cancer Institute Colorectal Cancer Risk Assessment Tool provides the most accurate estimates for a US patient population.*
